Treasurer's Report: Walter Dutcher reviewed the 2016 financial report and current assets. John Slater moved and Terri Mayhew seconded that the treasurer's report be approved, and the motion carried. Board Nominations: Rich Henderson introduced Matt Dombrowski, who was appointed to the board of directors in 2016.
